Treasurer's Report:

Bank balance as of October 31, 2005 was \$3,769.27. Revenues amounted to \$5,100.37 and expenditures at \$1,331.10. It is encouraging to have an increase in the number of paid members.

The Financial Report was moved by Murray Stevenson and seconded by Father Cheverie.

Constitutional Amendment:

Ivan Dowling moved that Section 7 of the Constitution be amended to have the number of directors changed from three to five. We would like to have representation of all the groups on campus, such as IBEW and CUPE 501. The motion was seconded by Mike Hennessey. No discussion and motion passed.

After a short break, President Wade MacLauchlan addressed the assembly outlining the academic and physical changes that have occurred on campus over the past year i.e.

- 3 books have been published about different aspects of the University.
- MPHEC's report on research from 1995-2002 has UPEI on top; MacLean's rankings has placed UPEI 8th for the past two years; Students awards UPEI is 1st out of 21 universities. New student residence to open January 2006; New soccer field opened in November;

- Fitness facility is a fantastic area;
- National Health Building is due to open the end of February 2006; _
- Duffy Science Centre is an amazing building since it has been completely renovated;
- Next year (2006) will see a new & renovated building for the School of Business;
- Expansion to the AVC building a new bioresearch complex.

Before leaving President MacLauchlan invited the retirees to the UPEI Christmas Social on December 20th at 3:00 pm in the Courtyard of the Murphy Student Centre.

Following the President's talk, a presentation was given by Philip Hooper on our **pension**; Ryan Johnston on **health**; and Gary Bradshaw on the **campus plan**.

<u>Pension</u>: Philip gave a detailed account of our pension plan - history and its status today. This year we might get a slight increase but don't count on a big indexing. Questions followed.

Health: Ryan indicated that the cost of the health plan was increasing by 15-17% per year. He mentioned a few ways that we could help to save and lessen the costs by:

- a) using the Provincial Senior Drug Plan
- b) using trial prescriptions
- c) shopping around for cheaper dispensing fees
- d) knowing your medications are generics available
