Overview:

The Netherlands Antilles consists of two island groups in the Caribbean Sea. Saba is part of the Netherlands Antilles Leeward Islands (northern) group which also includes Sint Eustatius, and Sint Maarten.


Industry:

Petroleum: Petroleum activities are administered by Saba Bank Resources NV a company jointly owned by the government of the Netherlands Antilles and the island governments of Saba, Saint Martin, and Saint Eustatius. Ecotourism, scuba diving, climbing, and hiking Seafaring

Niche Industry:

Saba lace, or "Spanish work", is a cottage industry on the island. Scuba diving, rock climbing.

In 1972 a pier was completed in Fort Bay to access the island and has made it easier for visitors to come there. Travel is provided by the Saba ferry Dawn II, as well as another ferry dubbed "The Edge". Approx. 25,000 visitors each year.

Saba is mainly composed of woodland forest with ferns and damp soil, and many mango trees. Many of the Mahogany tree stands were destroyed in the 1960s due to a hurricane. These trees are now considered at risk of extinction. Poor soils and inadequate water supplies hamper the development of agriculture.

4.3 km southwest of Saba is the Saba Bank, a large submerged atoll of rich biodiversity, and a prime fishing ground, particularly for lobster. Saba Bank



is a backarc basin on the west side of the northern Lesser Antilles, a slowly moving active margin island arc on the eastern edge of the Caribbean plate under which Atlantic oceanic crust is being subducted.

Critical Issues

The waters around the island were designated as the Saba National Marine Park in 1987, subject to government regulation to preserve its coral reefs and other marine life. Thus, Saba is known as the "Unspoiled Queen" of the Caribbean.

HISTORY AND CULTURE

History

Columbus was the first to sight Saba, but it was the Dutch who colonized the island in 1640 with a party from Sint Eustatius. Because of its difficult terrain, the island's growth progressed slowly, and it remains the least populated island in the Dutch Kingdom.

Referenda

Voters in the Netherlands Antilles have opted to dismantle the Netherlands Antilles and create new structures between the various islands and the Kingdom. St. Maarten and Curacao have opted for an autonomous country status within the Kingdom similar to Aruba's status. Saba, Sint Eustatius, and Bonaire have opted for closer ties to the Kingdom. The target date for implementing these changes is December 15, 2008, but it is unclear if this target will be met.

Music, Dance, Handicraft and Patrimony:

Carnival & Saba Summer Festival is held the 3rd week of July. Saba Day, December 7, 2007 is the 32nd anniversary.
